Dear SCPA Families:

On Thursday, February 11, 2021, the CPS Board of Education directed schools to provide a fully remote option at the home school for families not interested in enrolling at the Cincinnati Digital Academy (CDA). Therefore, families now have three options.

To clarify the difference among the options, here are the definitions:

- **Blended Learning** is in person two days a week and remote three days a week.
- **Remote Learning** is independent/asynchronous learning.
- **CDA** is all remote and separate from SCPA.

Blended learning offers an opportunity for the staff to address the social, emotional, artistic, and academic needs of SCPA students. We encourage families to choose the blended-learning option. SCPA is unique. The arts programming and pre-professional training are why you chose SCPA. We understand that some families are not ready or able to send their students back to the building for in-person learning. However, the remote-learning option is not the ideal way to support our creative students.

Blended Learning at SCPA

- Mondays are remote.
- Group A attends school on Tuesday/Wednesday. Thursday/Friday are self-directed.
- Group B is self-directed Tuesday/Wednesday and attends school on Thursday/Friday.
